

Your membership term is based on a calendar year cycle from January through December. Applications received after January 15 will be prorated. Your Moving & Storage membership covers one main branch at the primary flat or prorated rate. If your company has additional branches, the cost is \$250 per additional office branch.

- **Example 1:** Mehring Movers joins January 4 and has three branches. They will pay \$1545 (\$1,030 flat rate for primary branch+\$257.50 for each additional branch).
- **Example 2:** Blackmon Brothers Movers joins July 3 and has two branches. They will pay \$643.75 (\$1030+\$257.50 (two branches/12 (# of months in year)) multiplied by 6 (months remaining in year).
